

MLS Read-Only Participation Agreement

The undersigned appraiser desires to obtain Read-Only Access to the Telluride MLS. If the Telluride Association of REALTORS (hereinafter "TAR") accepts the appraiser for Read-Only Access, as evidenced by TAR's signature below, TAR will grant to the applicant a non-exclusive, limited license to access the Telluride MLS solely for use in preparing and collecting data regarding comparable sales in the applicant's appraisal business.

(For MLS access by Appraisers who are not members of the board/association and do not hold a current, valid Real Estate License.)

New applicants are reviewed and approved ONLY at our monthly board meetings, the first Tuesday of each month (subject to change—call for scheduling). MLS access will not be granted until that time. In order to have your application reviewed you must submit your completed application WITH payment to the Telluride Association of REALTORS®' Office one week prior to the Board meeting—no exceptions. Applications received without payment will not be considered.

I understand that TAR may terminate or suspend Read-Only Access at any time for cause upon any breach of this agreement, including the non-payment of fees and dues, and that TAR shall be entitled to keep all fees and dues paid by me prior to any such termination for cause. In addition, TAR may terminate this Agreement at any time without cause upon ten days written notice, provided, however, that upon any termination without cause, TAR shall refund a pro rata portion of the Annual Dues paid by me but shall be entitled to keep the application fee.
